Acknowledgement of Competition Use and Release and Assumption of Risk and Liability

THIS IS A "RACE ONLY" PRODUCT USED SOLELY FOR COMPETITION. Its use is limited to closed-course and open-course racing that is formally sanctioned by a recognized racing organization. Any other use, including recreational off-road use, could be in violation of local, state and federal laws. Please read, understand and accept all the terms of this Acknowledgement before purchasing and installing this product.

1. I am purchasing this DPF (diesel particulate filter) Delete System for my vehicle which I am repairing or modifying.
2. I am aware that the DPF Delete system is to be used solely for competition in a closed-course and open-course racing sanctioned by a recognized racing organization.
3. By signing below, I represent and warrant that I am purchasing the DPF Delete System for the sole purpose of installing on a vehicle that will be used solely in competition and not used on any public roadway, dirt or paved.
4. I understand that this DPF Delete System will not function properly on the vehicle unless an electronic module accompanies this system.
5. I understand that aFe does not provide an electronic module with this DPF Delete System and I must purchase an electronic module separately from another manufacturer.
6. I understand that if I use my vehicle for any purpose other than competition after installing the DPF Delete System, my vehicle may fail local, state and federal emission standards and testing and I may be subject to penalty and fines.
7. I understand that the installation of the DPF Delete System may void vehicle and engine warranty.
8. I understand that I must destroy upon installation of the DPF Delete System or I acknowledge that I have already destroyed the original emission label of the vehicle on which the DPF Delete System is installed.

In consideration of advanced Flow engineering (aFe) agreement to sell the DPF Delete System, I, on behalf of myself, my successors, assigns and affiliates (collectively the "Releasing Parties"), hereby release and forever waive and discharge aFe and its affiliates, successors, assigns, directors, officers, agents, representatives, employees and distributors (collectively the "Released Parties"), both jointly and severally, from any and all actions, covenants, claims and demands for damages or injuries (to vehicle or persons or property), and claims for penalties, fines, or other actions taken by any government authority, however arising, which may have been or may not have been sustained by, or in any way relating or arising out of the DPF Delete System (including, without limitation, any claims related to failure to meet emission standards, failure of the vehicle to used solely for competition and voided warranties.) I further agree to indemnify and hold Released Parties harmless from any such claims, including attorney's fees and costs.
